Consignment Seals.**

Bidding will be conducted through National Competitive Bidding procedure and is open to all internationally reputed Manufacturers and their authorized export agents abroad.

In case the manufacturer or his authorized export agents abroad submitting the bid directly, an authorized agent in Sri Lanka shall represent the manufacturer/authorized export agent abroad.

Sri Lanka local time (GMT+5.5) up to Wednesday, 04th December 2019**, upon payment of a non-refundable bidding document fee of **Sri Lankan Rupees Eight thousand five hundred (LKR 8,500.00)** per document. Bidders are requested to inspect the bidding document prior to purchase and once it is purchased, bidding document fee is not refundable for any reason whatsoever.

A Pre-bid meeting will be held at **1000 hrs. Sri Lanka local time (GMT+5.5) on Friday, 22nd November 2019** at the Office of Manager Procurement, Ceylon Petroleum Storage Terminals Ltd (CPSTL).

Duly filled bidding documents may be sent by registered post or sealed cover **to reach** the Chairman, Department Procurement Committee, C/o Manager Procurement, Ceylon Petroleum Storage Terminals Limited, Procurement Function, 01st Floor, New Building, Oil Installation, Kolonnawa, Wellampitiya, Sri Lanka or could be deposited in the tender box kept at the above address, on or before **1400 hrs. Bids will be closed at 1400 hrs. Sri Lanka local time (GMT+5.5) on Thursday, 05th December 2019 and will be opened immediately thereafter at the office of Manager Procurement, in the presence of the authorized representatives of the bidders who chose to attend.

All bids shall necessarily be valid for acceptance minimum until 05th March 2020.

All bids must be accompanied by a bid security for a minimum sum of Sri Lankan Rupees Three hundred fifty thousand (LKR 350,000.00) or United States Dollars Two thousand (USD 2,000.00), which shall be valid minimum until 02nd April 2020.
