PARTICULAR APPLICATION INCLUDING GENERAL NOTES FOR ICTAD CONDITIONS OF CONTRACT

Clause 2.3: ENGINEER'S INSTRUCTIONS

This shall be read in conjunction with Clause 2.3 of General Conditions of Contract.

- a) Any additional detail drawings issued to the contractor to assist him in his work during the course of repair shall not constitute a variation if it is given for purpose of clarity.
- b) Clear and comprehensive reports shall be maintained by the contractor during the agreement period and submit timely to the engineer for evaluation and to plan necessary actions.

Clause 6.1: EXECUTION OF THE WORKS

This shall be read in conjunction with Clause 6.1 of General Conditions of Contract.

a) Working Hours

- i. Normal working hours of CPSTL from Monday to Friday is from 0730 hrs. to 1645 hrs.
- ii. In the work programme Saturday also can be considered as a working day and from Monday to Friday up to 1800 hrs also can be considered as a working hours by the contractor. But to work on Saturday and up to 1800 hrs the contractor is required to obtain prior permission since the offices are normally closed on Saturdays.
- iii. However, working on Statutory holidays, Sundays and after 1800 hrs. on working days will not be permitted.
- iv. Provided always that provision of above (iii) shall not be applicable in the cause of any work which it is customary to carry out, outside normal working hours by rotary or double shifts.

b) Repair works to be carried out at Contractors premises

- i. Written request shall be forwarded to CPSTL informing intended repair work to be carried out, repair duration and parts to be taken out from LBD premises.
- ii. Contractor may be able to taking out parts on approval of request by CPSTL.
- iii. Contractor shall make necessary arrangements for engineer to witness tests carried out and inspect repair works at contractor's premises without any delay.

Clause 6.2: PROGRAMME

With reference to Clause 6.2 of General Conditions of Contract and additional to it, the programme of work shall be submitted within 14 days after receipt of letter of award.

Contractor should arrange his work in such a way that it will not interfere the day-to-day operational work of the relevant LBDs.

There shall be provisions made in the programme of work to cater for the acts and risks beyond control as stated in the conditions of the contract.

Contractor shall change this sequence of work,

- a) On the approval of the Engineer and if it is not affected to day-to-day operational activities of the relevant LBD.
- b) If Engineer is instructed to change the sequence of work due to unavoidable reasons.

Clause 12.1: CONTRACTOR'S CARE OF THE WORKS

This shall be read in conjunction with Clause 12.1 of General Conditions of Contract.

Special Safety Conditions

- i. Fire blanket are to be laid before starting hot work at site where ever required.
- ii. The work/workers should conform to the Fire & Safety rules and regulations of CPSTL and they should wear safety belts when working at high elevations.
- iii. Before work of any nature is commenced in any area it is necessary to obtain excavation permits, safety certificates and if the work involves sparks or flames also a hot work permit from the Fire & Safety Section of the relevant LBD depending on nature of work. All precautions stipulated in these documents must be observed by the contractor and his employees. If the work cannot be completed in the period for which these documents are valid the work shall be discontinued until the documents have been renewed.
- iv. All LBDs are security restricted area and all contractor's personnel shall abide by the security regulations prevailing and those which might be enforced as and when necessary due to changed circumstances.
- v. All contractor's personnel and their vehicles will be required to obtain gate passes before enter in to the relevant LBD. Those who possess valid police clearance are eligible to obtain gate passes. Safety clearances to be obtained before enter to the tank farm.
- vi. The contractor shall, except if and so far as the contract provides otherwise, indemnify the CPSTL against all losses and claims in respect of injuries or damage to any person or material or physical damage to any property whatsoever which may arise out of or in consequence of the execution of the works and against all claims, proceedings, damages, costs, charges and expenses whatsoever in respect of or in relation thereto except any compensation or damages for or with respect to:
 - a. the permanent use or occupation of land by the works or any part thereof:
 - b. the right of the CPSTL to execute the works or any part thereof on, over, under, in or through any land;
 - c. injuries or damage to persons or property resulting from any act or neglect of the CPSTL, his agent, servants or other Contractors, not being employed by the Contractor, or for or in respect of any claims proceedings, damages, costs, charges and expenses in respect thereof or in relation thereto or where the injury or damage was contributed to by the Contractor, his servants or agents such part of the compensation as may be just and equitable having regard to the extent of the responsibility of the Employer, his servants or agents or other contractors for the damage or injury.
 - d. General safety procedures and conditions on engine driven fire pump shall be adopted. Work shall be performed only after obtaining the confirmation from the Engineer (Engineer is the Engineering manager of CPSTL) that the fire system of the LBD ready for release the pump for service/repair. After completion of the work the Engineer shall be informed to operate the system.

6.0 SPECIFICATIONS

6.1 Scope of Supply by CPSTL

- 6.1.1 CPSTL Engineers representative will arrange the gate passes for the Contractors personnel, equipment and materials, hot work/ cold work permits and other permits related to the Work on request of the Contractor.
- 6.1.2 CPSTL will supply water and electricity as required. Other all requisites shall be supplied by the contractor for successful completion of the contract.

6.2 Scope of Supply of Contractor

- 6.2.1 Supplying of all transportation requirements.
- 6.2.2 Supply of All materials and spare parts for successful completion of the AMCA.
- 6.2.3 Supply of All tools and equipment where necessary.
- 6.2.4 The contractor shall provide technically qualified and skilled personnel at all the times, who are specially trained to troubleshoot, repair, maintain and servicing of engine driven fire pumps at all times.
- 6.2.5 Following minimum technically qualified personnel shall be deployed for every service/ inspection and their details shall be submitted with the bid.
- 6.2.5.1 Technical supervisor (Mechanical) NDT/HND 2 years experience.
- 6.2.5.2 Diesel Engine mechanic 5 years experience
- 6.2.5.3 Control system electrician 2 years experience
- 6.2.6 Supplying of skilled labour as mentioned in 6.2.3. Details of the skilled labour shall be submitted with the bid. Qualified single or more persons can be proposed at the bidding stage and the same persons shall be deployed for services and inspections. The engineer shall be notified, if any changes of the personnel and obtain the prior approval before any visit. Replacement of staff shall be performed with person having higher or similar qualifications as requested in the bidding document.
- 6.2.7 The contractor will be provided with a tentative schedule for service and inspection, taking into account previous services and the manufacturer's recommendations. It is

preferable for the contractor to attend on the scheduled date or within a one-week grace period. If the general service is not completed within 10 days from the scheduled date, Liquidated Damages (LD) will be applied as per Clause 2.11. The contractor must confirm the service and inspection dates with the Engineer prior to each visit.

- 6.2.8 Contractor shall provide service mentioned in 6.3.2 and 6.3.3 at the quoted rate in the price schedule within the contract period, if additional service is required.
- 6.2.9 Supply of all consumables necessary for the proper execution of the contract.
- 6.2.10 Contractor shall provide necessary safety gears for Contractors employees and proper tools and lifting equipment.
- 6.2.11 Supply of necessary testing and monitoring equipment other necessary equipment for successful completion of the contract.
- 6.2.12 Mentioned spare parts in the schedule shall be supplied and installed within 60 days from the date of purchase order is issued and part replaceable warranty shall be provided by the contractor during the AMCA period.
- 6.2.13 Contractor shall provide at least six month guarantee on supplying spare parts and for major repairs including workmanship.
- 6.2.14 A full time contact person (coordinator) shall be available for communication during the period of AMCA. The contact details of the personnel shall be submitted after signing the AMCA. Any changes of the coordinator shall be informed to engineer in advance.
- 6.2.15 Containers for placing removed items.

6.3 Scope of Work of Contractor

- 6.3.1 Contractor is responsible for maintenance, service and repair of all units of each pump mentioned in 6.5 during the period of AMCA.
- 6.3.2 Contractor shall provide one (01) "General service" for each pump and shall be attended after relevant working hours/ intervals of the engine as directed by the engineer.
- 6.3.3 Contractor shall provide three (03) "Inspection visits" for each pump in equal interval considering the general service attendance.

- 6.3.4 Contractor shall installed supplied spare parts mentioned in the Bill Of Quantities and rectify the existing faults of pumps. Supplying spare parts shall be installed after identifying the existing faults, deciding the suitability and agreeing with the engineer and shall rectify the fault. (Fuel feed pump DEFP 04, DEFP 05, Water pump repair kit DEFP 04, DEFP 05, DEFP 06, Cooling loop solenoid valve– DEFP 05, Pressure cap DEFP 06)
- 6.3.5 All removed items in replacement (oil, filters and spare parts) shall be handed over to Depot Superintendent, placing in a proper container (oil plastic canes, spare parts corrugated cardboard boxes, etc...) and each item shall be mentioned in the relevant report.
- 6.3.6 Contractor shall submit a report to the Engineer on completion of each inspection/service/ Breakdown repair. Contractor shall follow the formats of inspection/service/ Breakdown repair given by the Engineer. Report content not limited to given format and shall be based on manufacturer's maintenance instructions manual and NFPA25. Additional details shall be added with the agreement of the engineer.

6.3.7 Scope of Periodic Inspections (inspection visit)

- 6.3.7.1 General inspection procedures on engine driven fire pumps and instructions given in operation and maintenance manuals of the pump are applied. Contactor shall submit duly completed inspection report as per the format given by CPSTL conducting a thorough inspection on all parts of the pump but not limited to the items of checking as mentioned in the format.
- 6.3.7.2 General visual inspection, for any obstructions/ failures of Engine related systems, prior to start-up, for confirmations and identification of no major issues for safe to start-up. If any obstruction or failed part or system related issue were found, Engineer shall be notified and approval will be obtained prior to start-up.
- 6.3.7.3 On confirmation, run the engine and general inspection shall be carried out focusing on abnormal sound, instruments readings, smokes of exhaust, while on running. During the test run if any malfunctions were identified, the Engineer shall be notified of the malfunctioning item or system (Leaks/Instrument failures/ abnormal sound etc.)

6.3.8 Scope of General service

- 6.3.8.1 Scope of Periodic Inspections (inspection visit) shall be applied with followings.
- 6.3.8.2 Run the engine for few minute prior to take over the unit for routine service. Set main pump controller to "OFF" while servicing engine. Before turning the main pump controller to the "OFF" position, check with the fire superintendent and security supervisors of the depot to verify that relevant authority of the depot will be alerted of the temporary interruption of their fire protection equipment for normal maintenance or testing and safety precautions shall be adopted to prevent accidental start-ups.
- 6.3.8.3 Replacing of engine oil with recommended oil, oil filters, fuel filters, make of the replacing items shall be as mentioned in the contractor's offer.
- 6.3.8.4 Installing of service spare parts those are recommended to replace every two years period by the manufacturer.
- 6.3.8.5 Pump shall be re-started and a test run shall be performed to inspect the rated RPM, check for leaks, sound and rattle of guards and rectify any issues arising thereof. Stop and re-check the lubrication oil level. Start and run for few minutes and load the pump with available load for 10 minutes, with participation of fire superintendent.
- 6.3.8.6 Hand over the service report following and duly filled the given format with the duly filled inspection report mentioned in the periodic inspection.

6.3.9 **Breakdowns**

- 6.3.9.1 Contractor shall attend emergency breakdown inspections within 24 hours of the notice of the Engineer. Failure to do so, it is considered the contractor's performance are poor and leading to be suspended on applying for AMCA for one year period.
- 6.3.9.2 Contractor shall carryout minor repairs categorized as adjustment and repairs and replacements below Rs. 2000/= under the AMCA Free of Cost. If the contractor could able to solve the failure in the visit, the cost shall be claimed after the visit.

6.3.9.3 If the failure is a major repair, the contractor shall provide a repair Estimate on measure and pay basis to the Engineer (other than specified in 6.3.9.2) and attend the repairs upon receiving Authorization from the CPSTL.

6.4 Specifications, Material and Spare parts

- 6.4.1 Contractor shall provide only the manufacturer's recommended genuine spare parts, filters, lubricating oils and coolant. All filters shall be of CLARKE or OEM (Jhondeer) branded. Offer shall be mentioned in the bid.
- 6.4.2 Contractor shall convince the CPSTL engineer for supplying spare parts are right item and genuine before installation. The contractor is obliged to provide any relevant documents as requested by the engineer for clarifications. The whole responsibility of supplying right spare parts is of contractor.
- 6.4.3 Lubrication oil shall be SAE 15W40and should meet the requirement of API service CJ-4. Please refer the engine operation and maintenance instruction manual of the relevant engine for further details.
- 6.4.4 Lubricant oil and coolant quantity shall be supplied in originally sealed plastic containers such as 4l, 5l, 10l or 20l capacities. Contractor shall obtain the approval before use for the engine.

2.TERMS AND CONDITIONS

- 2.4 The contractor shall provide service mentioned in 2.1 and 2.2 at the quoted rate in the price schedule within the contract period. In case of an additional service is required, it will also be performed as per the quoted rate, specified in schedule –A.
- 2.5 The scheduled inspection and Routing service to be carried out by the contractor shall be during general working hours (General working hours are from 07.30 am to 04.30 pm from Monday to Friday excluding mercantile holydays).
- 2.6 The contractor shall provide on call urgent inspection for repairs and maintenance within 24 hours from the information received, without considering general working hours specified 2.5, inclusive of labour and transport charges.
- 2.7 Attending to Equipment failures /Damages occurred due to Lightning, Power fluctuations, flooding shall not be covered under this AMCA but it would be attended after analyzing the gravity of the damage and approval of the estimated additional charges by the CPSTL.
- 2.8 Relocation of the Equipment from the existing place of installation shall not be covered under this AMCA.
- 2.9 The terms and conditions of the bidding document shall govern.

3. RESPONSIBILITIES OF THE CONTRACTOR

- 3.1 Attend inspections and services as per the schedule to ensure the optimal performance of the pump and engine.
- 3.1 On notification of any failure or unusual performance of the equipment, to carry out in a timely manner, to provide uninterrupted service considering fire risk,
 - a. Inspection and breakdown service shall be attended at the quoted rate in the price schedule without an advance payment.
 - b. Submission of relevant report to CPSTL.
- 3.2 Shall submit a report in the standard format on completion of the scheduled inspection / routing service / repair.
- 3.3 The maintenance program would be based on the specific requirements of each equipment unit covered by this agreement and manufacturer's recommendations, guidelines and as per the NFPA25 *Standard for the Inspection, Testing, and Maintenance of Water-Based Fire Protection Systems*, latest edition.

- 3.4 Shall provide only the manufacturer's recommended genuine spare parts, filters, lubricating oils and coolant under this agreement as per the price specified in schedule-A.
- 3.5 Deploy competent and well qualified personnel all the time.
- 3.6 A full time contact person will be available for communication during the contract period and any changes will be notified as soon as possible.
- 3.7 Shall provide a repair Estimate on measure and pay basis to the CPSTL for Major repairs (other than specified in 2.3) and attend the repairs upon receiving Authorization from CPSTL.
- 3.8 Reviewing of daily and weekly routing inspection reports carried out by CPSTL and ensures the good performance of the equipment and inform CPSTL if fault is found.
- 3.9 Inform attendance to CPSTL with relevant details keeping ample time period to arrange relevant passes.
- 3.10 All removed items in replacement (oil, filters and spare parts) shall be handed over to Depot Superintendent, placed in a proper container (oil plastic canes, spare parts corrugated cardboard boxes, etc...) and each item shall be mentioned in the report.
