

## CEYLON PETROLEUM STORAGE TERMINALS LIMITED INVITATION FOR BID (IFB) <u>INTEGRITY ASSESSMENT OF CPSTL OFFSHORE / ONSHORE PRODUCT PIPELINE</u> <u>SEGMENTS BY INLINE INSPECTION</u>

- The Chairman, Procurement Committee on behalf of the Ceylon Petroleum Storage Terminals Limited, Oil Installation, Kolonnawa, Wellampitiya, Sri Lanka now invites sealed bids from eligible and qualified bidders for õ*Integrity Assessment of CPSTL Offshore / Onshore Product Pipeline Segments by Inline Inspection*ö as described below
- 2. The work consist of Inline Inspection of two 18ö dia. (approximately 7300m each), one no 24ö dia. (approximately 1130m), one no. 14ö dia. (approximately 1680m) and two nos. 12ö dia. (approximately 930m) offshore/onshore product pipelines by Inline inspection,ö by running intelligent pig based on Ultrasonic Technique (UT) to detect and quantify internal and external corrosion/ mechanical defects and other anomalies, preceded by High Density Polyurethane (HDP) foam Pig (as confidence builder) Proving, Cleaning, Gauging, if needed, Corrosion Detection pig runs and preparation & submission of comprehensive report.

The Intended Service Period is 120 days.

- 3. Bidding will be conducted through International Competitive Bidding (ICB) Procedure Two Envelop method.
- 4. To be eligible for contract award, the successful bidder shall not have been blacklisted.
- 5. Qualification requirements to qualify for contract award include
  - 5.1. Average annual volume of work (petroleum product pipeline inline inspection) performed in last five years shall be at least **LKR 720 million** or equivalent amount in foreign currency.
  - 5.2. The minimum amount of liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments, which may be made under the Contract, until the project is taken over by the CPSTL, shall be not less than **LKR 120 million** or equivalent amount in foreign currency.
  - 5.3. The experience of the Bidder in õintegrity assessment of petroleum product pipelines by Inline Inspectionö during last five years shall be as follows.

Bidder should possess experience as a prime service provider in the integrity assessment of petroleum product pipelines by Inline Inspection of a nature and complexity similar to the Works (1500m or longer segments of 10ö dia. or higher dia. pipelines), minimum three projects including at least one offshore and one onshore segment in a single project or in separate projects, as per API Standard 1163 and other relevant standards), during last five years. At least one of the projects shall be carried out by Ultrasonic Technique (UT).

6. No liability will be borne by CPSTL on loss or late delivery. Bidding Document (excluding drawings) available in the web is only for viewing purpose and Bids shall be submitted using Hard Copy of the Bidding Document purchased from CPSTL.

- 10. All bids shall be accompanied by a Bid Security of LKR 4,790,000.00 (Sri Lanka Rupees Four Million Seven Hundred and Ninety Thousand only) or USD 16,250.00 (US Dollars Sixteen Thousand Two Hundred and Fifty Only). Bid Security shall be valid up to **01.12.2022.**
